DNAs will have to carry out EEP activities as assigned by this Council from time to time through Ecoclubs formed under the erstwhile central scheme-National Green Corp (NGC) Programme or other such units formed under various schemes of Ministry of Education, Youth Clubs of Nehru Yuva Kendra Sangathan, National Service Scheme (NSS) Cells/ Units, etc., formed under various schemes of Department of Youth Affairs (DoYA), Child Care Institutions (CCI) or other such units formed under various schemes of The Ministry of Women and Child Development (MoWCD), etc.
- 5. Although there is not any provision for separate Eco Club grants under EEP, the DNAs have to encourage all the existing Eco Clubs to carry out their scheduled activities on environmental awareness and conservation. Moreover, new Eco Clubs may be enrolled through our Web Portal https://ngcassam.in/.
- The Director, ASTE Council reserves the right to cancel any DNA, if found disadvantageous to ASTEC and the concerned district authority without assigning any reason thereof.
