Size- Demy Size; **Binding** – Wire binding

Quantity – 250 (Two Hundred and Fifty) copies; **Paper** – 220 GSM Art Paper

Multicoloured Annual Calendar design, layout, printing with both English and Assamese months with some almanac details (like waxing and waning of moon information) along with list of Government of Assam holidays, restricted holidays, half holidays, important days for individual months (January to December 2023) with photographs.

1. Those who have already submitted quotations need not submit again.
2. Quotations of Printing Press registered under the Category "A" of Printing & Stationery Department, Govt. of Assam will be considered.
3. PAN as well as GST numbers are to be clearly mentioned.
4. Quotation in the sealed envelope should be superscripted with "Quotation for ASTEC Annual Calendar 2023"
5. Sealed Quotation should be submitted separately in two bids –
 - (i) **Technical Bid** : Following documents are to be inserted into Technical Bid:-
 - (a) IPO of Rs.20.00 only or Court Fees of Rs. 8.25 only.
 - (b) Samples of the paper mentioned.
 - (c) Two sample copies of such work already printed by the firm in the year 2021 and 2022.
 - (d) Authenticated photocopy of PAN and GST Number.
 - (e) Valid photocopy of the registration certificate of the Printing & Stationery Department, Govt. of Assam
 - (ii) **Financial Bid** : Financial Bid is to be submitted in prescribed format separately and the same will be considered / opened of those firms/ parties who would duly qualify in the Technical Bid.
6. Rates should be quoted inclusive of all applicable taxes; transportation etc and applicable tax will be deducted at source against which necessary Tax Deduction Certificate will be issued as and when required.
7. Rate should be valid for 1 (one) year.
8. A Provisional Work Order will be issued with details of holidays etc., along with photographs. The firm has to submit 2 (two) consecutive proofs within 15 days from the date of receipt of the Provisional Work Order. The Final Work Order will be issued after necessary checking of proof.
